GRANTING of an ALL ALCOHOL RESTAURANT and ATTENDANT LICENSES

WHEREAS, Castaway's @ Olde Scotland Links, Inc. has submitted all applicable documentation as required for new All Alcohol Restaurant and attendant licenses; and

WHEREAS, the petitioner has described the service premises as:

Clubhouse and function facility located at 695 Pine Street, Bridgewater, MA consisting of 395 +/- sq. ft. kitchen; 750 sq. ft. lounge area; 1800 sq. ft. patio; 1320 sq. ft. deck; 2600 sq. ft. function room; 2 bathrooms; a lobby area; a coat closet; and front and rear entrances, tent area, and the 18 holes of the golf course as shown on the golf course layout dated as of May 30, 2012 attached hereto and marked as Exhibit 1, with beverages to be sold from 2 beverage carts on such 18 holes.

WHEREAS, approval of request to sell alcoholic beverages is required by Massachusetts General Law – Chapter 138, section 12 prior to the final submission to the Commonwealth's Alcohol Beverages Control Commission who must ratify the action; and

WHEREAS, the hours of operation for the food establishment will be: Monday - Sunday 6:00 a.m. – 1:00 a.m. and the sale of alcohol will be permitted only: Monday - Saturday 8:00 a.m. – 1:00 a.m. and Sundays 10:00 a.m. – 1:00 a.m.

WHEREAS, Castaway's @ Olde Scotland Links, Inc. has complied with the policies and requirements of the Town of Bridgewater; and

WHEREAS, the Bridgewater Town Council, acting as the Legislative body of the Town has such licensing authority and with the affirmative recommendation of the Bridgewater Building Inspector with consensus from the Fire, Police, and Health Departments who have oversight authority, it appears that the public good so requires such license be granted;

The Town Council of the Town of Bridgewater, Massachusetts, pursuant to Chapter 138, section 12 and Chapter 140 - section 2 and section 6 respectively of the Massachusetts General Law (MGL), in Town Council assembled approve the petition of Castaway's @ Olde Scotland Links, Inc. to operate an establishment and sell alcohol on the premises of the Olde Scotland Links golf course 695 Pine Street, Bridgewater, Massachusetts as requested.
