APPROPRIATION FOR ANIMAL CONTROL VEHICLE

ORDERED, in accordance with section 6-4 (d) of the Bridgewater Home Rule Charter, that the Town Council vote to appropriate and transfer the sum of \$ 30,000.00 from Prison Mitigation for the purpose of purchase of a vehicle for the Animal Control officer; and that the Town Manager is authorized to take any other action necessary or convenient to carry out this project. The vehicle will be paid out of fund 1000, the General Fund Capital Fund.

Explanation: The Animal Control vehicle has failed. Continuing repairs is cost prohibitive. The transfer requested will allow the Town to procure a vehicle and outfit it for this purpose.
