I have been a Bridgewater resident since I was hired to teach environmental geography at Bridgewater State (College) University in 1997. I have spent most of that time as a director or officer of the Natural Resources Trust of Bridgewater, which has helped me to be acquainted with a range of local environmental concerns and related questions of governance. I am not a forester, but I do have a long and varied acquaintance with forests and trees, beginning with my work for two years as a landscaping contractor many years ago in Baltimore.

Both my master's and Ph.D. work involved forests -- Miami Whitewater Forest in Ohio and the Brazilian Amazon, respectively. I studied soil erosion and hydrology in the Ohio study and the political ecology of deforestation in the Brazil study. At BSU, my Land Protection class involves regular visits to two forests and related readings. Professional forest ecologists at both places -- Harvard Forest and Marsh-Billings Rockefeller National Historic Park -- taught me enough that I can continue to teach about them after those experts have retired.
