MEETING MINUTES

A Quorum of the Town Council was in attendance

A. CALL TO ORDER

A quorum of the Town Council being duly present, Town Council President Perry called the meeting to order at 7:00pm on Tuesday, October 28, 2024.

A quorum of the Town Manager Preliminary Screening Ad Hoc Committee being duly present, Chair Paul Murphy called the meeting to order at 7:00pm on Tuesday, October 28, 2024. The meeting took place via Zoom.

Fred Chase, Dr. Kevin Perry, Susan Robinson, Paul Murphy and Timothy Fitzgibbons.

Also present were Councilors Mark Linde and Mary McGrath.

B. APPROVAL OF MEETING MINUTES

a) October 22, 2024 Meeting Minutes

Councilor Chase made a motion to approve the minutes from October 22, 2024. This was duly seconded by Councilor Perry.

A roll-call vote was taken with the results recorded as follows:

Fitzgibbons – Yea; Chase – Yea; Perry – Yea; Murphy – Yea; Robinson – Yea.

Motion Passed 5-0.

D. ITEMS TO BE DISCUSSED

a) Discussion and Selection of Search Firm

Councilor Murphy noted that 3 search firm proposals were received, each were rated and interviews were conducted on October 22nd.

Councilor Perry noted that all interview were good and he ranked them as 1 = Community

Paradigm, 2 = MRI and 3 = Groux-White. Like Community Paradigm expansive team.

Councilor Robinson noted that she also ranked them 1 = Community Paradigm, 2 = MRI and 3 = Groux-White. All 3 firms were good but Community Paradigm had better networking strategies and MRI recruited the former Town Manager into his new position.

Councilor Chase noted that his choices were also Community Paradigm, MRI and Groux-White and that the interviews validated his choices. All had great experience but felt Community Paradigm had the best response to his question.

Mr. Fitzgibbons noted that he agreed with the others, feel that Community Paradigm is a good fit for the town.

Councilor Murphy noted that he also rated them as Community Paradigm, MRI and Groux-White and felt that Community Paradigm had the most comprehensive approach to the process.

Mr. Fitzgibbons made a motion to recommend Community Paradigm, subject to verification of pricing and negotiations, to the Procurement Officer as the search firm for the Town Manager search. This was duly seconded by Councilor Chase.

A roll-call vote was taken with the results recorded as follows:
Fitzgibbons – Yea; Chase – Yea; Perry – Yea; Murphy – Yea; Robinson – Yea.
Motion Passed 5-0.

Councilor Murphy noted that he will speak with Acting Town Manager Blythe Robinson.
